**B. EXECUTIVE DIRECTOR'S REPORT**

1. FY2013 BOC Calendar – July 9 (Exam Administration) and September 10  
Staff will add the FCLB Regional Meeting dates to the calendar. Staff and the Board will work together to plan the FY2014 calendar.
2. FCLB Regional Conference – September 18-21
3. BOC Census  
Currently there are 83 active chiropractic licensees in the District, of which 63 have ancillary privileges in physiotherapy.
4. BOC Vacancies Update  
The new Chiropractic Member application is pending DOH agency approval. The Executive Director encouraged the Board to seek out consumer members.
5. BOC Newsletter Update – Spring Issue  
This will be a post-renewal newsletter, which will go out in June. It will be re-titled as a Summer Issue. The Board Chair's appointment to FCLB will be featured in the newsletter.
6. 2012 CE Audit  
100% audit of chiropractors is currently underway and the deadline for CE submission in May 31, 2013. Board Members will review deficient licensees at the July meeting. The fine is \$50 per CE deficient, the attorney will send out an NSA accordingly. Some licensees may be asked to come before the Board, while others will be listed on an Executive Consent agenda.
